Greetings, Well it's another New year! Hopefully everyone had a happy holiday season. January has been quite a chilly month this year, but it sure is nice to see normal snow amounts! Staff are back in the office as of January 31, 2022.

The Chamber of Commerce of Sault Ste. Marie has put a pause on distributing rapid tests for the time being. These were being distributed to staff and their family. Individuals are still able to be tested with Natalie within Sault Ste. Marie using the Molecular Covid Testing machine. This is also available for members residing in Sault Ste. Marie and appointments can be booked via email to ngauthier@missanabiecree.com

We are continuing with the PCD distributions for those that are coming in on a weekly basis. A few members that we had not had contact from previously have come forward to collect their 2019 Treaty Land Entitlement Distributions. There are less than a handful from the original list now that we are unable to locate.

In working through the 2019 PCDs over the last couple weeks it has been identified that the distribution account has exhausted the original funds that were transferred for the 2019 distribution. This is due to new eligible members that have been added to the distributions and the bank will now be taking over any remaining payouts through the Trust account directly. This has required a change in the process for payments. Going forward, members who have not yet received their 2019 PCD will now be provided with a Beneficiary Form and Band Council Resolution will be used to direct CIBC to pay out those individuals.

Many reports are coming due and key staff are working with Finance to obtain the financial reports needed to complete these.

We are able to resume appointments for status card renewal. In order to book an appointment please contact June Markie. You must wear a mask and sanitize your hands upon entry for your appointment. Please note the following recent announcement from Indigenous Services

Canada regarding the extended validity date of status cards that was introduced in April 2020 due to the COVID pandemic.

"Since April 2020, Indigenous Services Canada (ISC) has extended the validity date of status cards and Temporary Confirmation of Registration Documents due to the COVID-19 pandemic.

This extension will end on May 1, 2022.

If your status card is past its renewal date, you should renew it now.

Submit a complete application for renewal by February 28, 2022 to allow for processing time and avoid delays.

You can ask for a Temporary Confirmation of Registration Document if you need proof of registration while waiting for your new card.

Indian status does not expire. Your registration number confirms your status and can be used to access some services and programs."

The Lands and Resources
Department has been already
very busy n 2022 working at
managing in a good way, all
matters related to Mining,
Forestry, Lands, and Waters.

The Land Code Subcommittee is working on part 3 of the draft Land Code for the nation, with plans to present to the Elder's Council next week and at a community forum by Mid-February. The Emergency Management Planning Subcommittee is working at drafting a master emergency

response plan, scheduled to take Hazard Assessment and Risk Identification training and looking to recruit members residing in (or close to) Missanabie to become part of the emergency response team. The Energy Management Subcommittee has been investigating cogeneration plants (as an identified goal in the Community's comprehensive plan) and the department is working on hiring a Community Energy Champion by early March (the job posting closing date has been updated to Jan 31/22).

There is also a new job posting that members may be interested in, that for a Marine Research Assistant. Missanabie Cree First Nation is working with Mushgekowuk to help inform a preliminary study to defend that the James Bay coast needs to be designated as a conservation area. Don't let the job title throw you off though, this job is all about community engagement to collect Indigenous knowledge of all kinds. The first project for the Research Assistant is to coordinate the Terra-Stories Naming Project. This project

aims to collect members stories and experiences of being out on the land, whether hiking, fishing, hunting, gathering or on spiritual quest. The stories will be compiled geo-spatially and help to inform the renaming of the various lakes, rivers, trails, hills and valleys. It is a way of taking back the land and helping to ensure the Cree legacy. Naming these features will further establish Missanabie Cree's Jurisdiction of its traditional territories.

We also have another project Traditional Territory. We are looking for members interested in participating in a two-part workshop (approximately 1.5 hours each session) to discuss species at risk in the homelands and how together we can help their populations recover. These sessions are being scheduled in February. Please look for the posting on Facebook and Missanabie Cree's website.

I hope everyone is staying warm. The days are getting longer and the sun is shining stronger.

How do you know if you are ready for post secondary schooling? It is the first question you should explore. Learn as much as possible about the school of your choice, the courses and prerequisites required, the costs involved, what will suit your housing needs, best-on campus or private rental. The costs involved in private rental can be hard to meet on a student living allowance so it would be best to do the research.

Something to consider is a college entry course. This could help tremendously in preparing you for college or university.

When you are ready to make the

Post Secondary Student Support Program (PSSSP) POLICY, GUIDELINES AND PROCEDURES Approved December 07, 2021 by Chief and Council.

The guideline includes topics that you need to know and understand, for example Eligibility, Student Responsibilities, Application and Approval Process and so much more. An example of high importance is in the Student Agreement that states:

- 3.2 It is the responsibility of the student to provide
- a) Transcripts for each semester. Failure to do so shall result in a non-deposit of your living allowance.
- b) Maintain a minimum average for your program
- c) You are encouraged to attend all classes according to program

- d) Inform the Education Officer of MCFN of any program changes and/or courses withdrawal with dates in writing e) You must disclose academic deficiencies, failure to submit transcripts will result in automatic discontinuation of post-secondary sponsorship f) It is the responsibility of the student to inform Missanabie Cree First Nation of changes to banking, telephone, address, email, and other contact information.
- g) Must contact the Education Officer monthly to update progress and discuss any issues or concerns
- h) Students are also encouraged to apply for Student Assistance Programs offered by the province as well as apply for scholarships/bursaries to help offset the expenses of their post-secondary education.

The education officer reserves the authority to withhold living allowance funds from a student if communication mandate is not met.

Greetings. Wachey, Aanii, Boozho, Our office was closed for the Christmas Holidays however I've been busy with a number of major projects throughout that time. I did have a wonderful Christmas and New year's with close family and friends and trust that the MCFN membership did as well.

MCFN and Garden River First Nation continue to work together on negotiations with Alamos Gold and our team has been liaising with their contract manager to prepare our partners for more opportunities being released this month.

Also, we continue to work with Argonaut at the Magino mine site with some of our companies successfully securing contracts as well.

We also have been supporting MCFN's Lands and Resources Department in negotiating new contracts with exploration companies, and I continue to represent MCFN at Wahkohtowin Inc. The board and staff at Wahkohtowin has completed a new strategic plan in the fall and are working on finalizing an implementation strategy for the next 5 years. Some of the major projects have been progressing quite rapidly. Our company ISN Maskwa will be delivering Emergency Management training February to March 2022 and is positioning itself to provide evacuation coordination to Kashechewan and Fort Albany, and is also training a number of Indigenous security guards and incident commanders for this year's flood, pandemic and fire seasons.

We have launched the Belleville Affordable Housing GP with partners Garden River, Mohawks of the Bay of Quinte and a private developer from Ottawa. We will begin converting a former federal office building in Belleville for affordable Indigenous housing early summer 2022 with an expected completion date in May 2023. We will use this



Dear Missanabie Cree First Nation Members,

As you might be aware there is a contingent of Members that have begun establishing themselves around Dog Lake. We as Chief and Council are inspired by our community's excitement to establish home on the Missanabie Cree First Nation Reserve — our Reserve. It was a long and hard fight to acquire this land, but all of the effort has been worth it, we finally have our reserve. We knew that it would be difficult getting here, but our hope was always that the next generation would grow up on Missanabie Cree land. Our children will.

The *Indian Act* imposes legal hoops and other limitations on how we can manage *our* land. Our hope was always to have land managed by Cree custom, not the *Indian Act*. To accomplish this, we became a signatory to the *Framework Agreement on First Nations Land Management* ("Framework Agreement") in July 2021. And although there will be more work to achieve self- governance even after this, the Framework Agreement allows us to manage our land according to our culture and laws. However, this step towards self governance is neither quick nor easy.

Once we complete the work required by the Framework Agreement we will have our own Land Code, our own laws. Our goal was never to acquire land for the sake of land, we wanted our whole community to benefit. As Chief and Council, we believe that *properly* setting up a Land Code is the best way to move forward. To make a Land Code official the community must be consulted and will ultimately vote on a path forward with which it believes. There are still limits on what the federal government will allow in a land code, but in short, a Land Code will allow the Missanabie Cree First Nation to opt-out of 44 sections of the *Indian Act*.

Currently for any Member to possess land on reserve the Minister of Indigenous Services from the federal government must approve, as required by Section 20(1) of the *Indian Act*. The transfer of land also currently requires approval by the Minister, required by section 24. We are long past these types of interferences from the Canadian government and through a land code we will be able to make our own laws governing these situations. Our eventual Land Code will remove us from under these patronizing sections of the *Indian Act*.

We ask for any members who have begun living on the reserve to *immediately* stop further development. It is the hope of Chief and Council that we can create a fair process where Members move onto the reserve fairly with the infrastructure to support a community for generations to come. As a community we will decide how to move forward and what ought to come of the land. We invite any individual who has begun establishing themselves on reserve to relocate off reserve as the community determines what our next steps should be.

We did not expect any development on reserve and as such there are no protocols to prevent the spread of COVID-19. Our land does not yet have the proper infrastructure to host long term living. Because of this there are present and serious concerns for the health of both the land and individuals who live there. There is no waste or water treatment systems and we are especially concerned for the safe disposal of blackwater. There are no waste sites yet developed and we unsure of where, or how, debris and other garbage is being disposed or stored. There has been no approval for any structure built on the land and

there is no guarantee that any of the structures were built according to safe and enduring measures. We are concerned for the effects of the current patchwork method of development and how it will prevent the sustained and safe development of our community in the future.

Our goal for this land was always to do the right thing the first time. We worry for the long-term negative effects of these types of knee jerk decisions.

At this time, and in the spirit of collaboration, Chief and Council will not pursue any legal recourse against those Members who have begun establishing themselves on reserve. However, any further development will be swiftly addressed. Ordinary possession of reserve land is granted through sections 20 and 21 of the *Indian Act* through Certificates of Possession. At this time no one on the reserve has a certificate of possession.

We do not believe that there is any malicious intent in those who have begun establishing themselves on reserve. We hope to move forward together as a community and guided by our seven grandfather teachings.

We have a vision of our community re-established on the traditional lands
that were once the homeland of our ancestors
where institutions of our government, economy and education can once again thrive.

We have a vision of a people where individuals and families can stand strong and find healing through tradition and spirituality; individuals and families who are loving and compassionate.

We have a vision of a people who are bi-cultural and bi-lingual;

a people who can walk in both worlds contributing to our well-being,
the well-being of other Indigenous Peoples; contributing and competing globally.

We have a vision of a Nation of people who respect the dignity of all;

a people who find balance through equality.

We have a vision of people who respect the environment, harvesting and reaping the resources of the land in a sustainable manner as responsible stewards for the use of future generations.

We are the Omushkego of the Missanabie Cree Ililiwak; whose vision it is to regain and restore our rightful place and through the strength of our people, never again be denied our place in society.
